TENNIS NZ SERVICE HONOURS TE TOHU HĀPAI



Guidelines for making Nominations

Please read these carefully before completing the nomination form

Te Tohu Hāpai – to support, carry, lift or elevate (dedication to the sport) encompasses and recognises a wide range of service both on the national level and within the tennis communities in New Zealand, with the following paramount benchmarks:

He Ngakaunui - Dedication/Commitment to tennis He Manaakitanga nui - Care/Impact on tennis Kaitiakitanga - Stewardship/Guardian of tennis

Such recognition (Ngakaunui) of roles within the sport can be evident broadly across all forms of the sport, being service to the sport over a lengthy period of time, and include playing of the sport on a national or international level, administration, officiating, coaching and volunteering.

Within these paramount benchmarks (paearu) the Honour reflects dedication to and love of the sport, selfless commitment to its advance, making a difference and enhancing the sport for those around them for future generations.

NOMINATION & AWARD PROCESS

Nominators Regions, Affiliates, Tennis Associations, Sub-Associations, and Clubs who are entities within

the tennis system governed by Tennis NZ.

When considering 'service' not only the **length of service** should be considered, but also the **quality** of the service. 'Quality' may include the type of service (and range of different activities) as well as how this has contributed to Tennis. When considering service as a player, only national and/or international playing experience should be considered, ideally with additional service in other ways to Tennis in New Zealand.

Voluntary/paid service Service in the course of employment may be detailed as 'service' for the award,

but it is not sufficient on its own. It is expected that a nominee will have contributed most of their service as a volunteer. Details of employment must be provided – $period\ of$

employment, fulltime or part-time (specify details), contract details etc

Closing date Nominations must reach Tennis NZ by 5.00pm **31 July 2024**.

Late applications will not be accepted.

Nominations Nominations must be made on the Te Tohu Hāpai Nomination Form (available on the

Tennis NZ website) and may be submitted electronically or in print form. The nominator is

responsible for ensuring all information provided is true and correct.

Consideration Nominations will be forwarded to the Tennis NZ Honours Selection Panel. The Panel will consider

each nomination and determine whether an award should be recommended or declined. The Panel is not able to enter into discussion regarding a nomination. As the final outcome will not be

known for some months, it is desirable that nominees are unaware of their nomination.

Decisions

The Panel will forward notes of its decisions to Tennis NZ by **11 September 2024** and will arrange for notification of the outcome to nominators, and where appropriate, to recipients, in the course of September.

Award

The awards will be announced at the Tennis NZ AGM and the formal presentation of the Honours will later take place at the Tennis NZ Awards Evening.

COMPLETING THE NOMINATION FORM

Comments on the form should be kept within the spaces provided

Nominator The responsibility for completing the nomination form rests with the nominator and with

the person who signs the form for that nominating entity. This person accepts

responsibility for the accuracy of material provided – $\it if there is uncertainty about any$

details this must be clearly stated.

Adequate time should be given to collecting and checking material (4-6 weeks suggested). Supporting information should cover the most important points and be clearly outlined.

Endorser The endorser must come from a different entity than the nominator. The form requires the

endorser to provide a statement of support (which may include additional information).

Tennis CV A separate 'Tennis CV' must be attached as an addendum to the nomination. This should

list the nominee's involvement in Tennis, including details of years and entities where

these have occurred.
