## INSIGHTS | CHAIR & CEO REPORT

#### **INTRODUCTION**

2018-19 has been a very progressive year where we are now seeing positive outcomes from the tennis in New Zealand strategic framework. The Tennis NZ team has worked alongside the tennis community to produce some excellent results and we are seeing a strong increase in strategic alignment and partnership across the tennis community. This has been a significant contributor to a large number of the very positive outcomes that you will read about throughout the Annual Report.

The Tennis NZ team was largely new in their roles at the beginning of this financial year however they have been very committed to supporting each other and the tennis community having grown in experience and knowledge very quickly. We farewelled Jo Toebosch at the beginning of this year and welcomed Liesl Ploos van Amsel who very quickly picked up where Jo left off in providing all administration support for the team. We also bid farewell to our Fed Cup Captain Neil Carter and welcomed in his place Sacha Hughes (Jones). Finally, we welcomed Matt Alexander to the coaching team to replace Finn Tearney, and Gareth Archer to the new role of Commercial and Marketing Manager. We wish Jo, Finn and Neil the very best and thank you for the contribution you have made to our sport.

#### **LOOKING BACK OVER 2018-19**

At the beginning of the year, Tennis Auckland again hosted two very successful weeks of International Tennis. Congratulations to the Board and staff of Tennis Auckland – the ASB Tournaments are nationally recognised as one of New Zealand's premier events. We also acknowledge the commitment of Tennis Auckland to gain the significant funding required for the upgrade of the venue at Stanley Centre.

The 2018/19 year bucked the declining membership trend – overall participation in tennis increased by 3.3%, (3% in the 2017/2018 year) with membership growing by 1.9%. An overall increase in membership is a first for many years! A variety of factors contribute to this – established national programmes, innovative clubs offering more appealing membership options, investment in coach development and volunteer training, and great initiatives like Love Tennis.

Importantly, 90% of national programme deliverers (professional coaches and clubs), agree that programmes add value to their business or club. This, coupled with Tennis Hot shots parents' feedback that 95% of participants rate the programme high or very high quality, gives us confidence that we have world class and proven products which enhance tennis in New Zealand.

Coach development continues to be a strong focus with 178 aspiring new coaches completing the 2hr Coaching Fundamentals online course. This was an increase of 76% from 2017-18 (101 coaches) and 16 Coaching Assistant Courses (3-day course) were delivered to a total of 170 participants.



This was an increase of 113% from 2017-18 (7 courses/80 participants). With the assistance of a growing Coach Developer network, this course was delivered in every region across New Zealand.

The ClubSpark roll-out continues well with over 50 clubs now using the platform. The Book-a-Court pilot took longer to complete than we initially expected due to development challenges however from this pilot there is now a refined system in place to manage the process with a further 20 clubs targeted this calendar year.

The Tennis NZ board has committed an investment of up to \$100,000 per annum to financially support approved clubs to install Book-a Court and as part of this investment is offering a subsidy of up to 80% of the basic installation costs per club. In the 2018/19 financial year Tennis NZ also secured a grant of \$50,000 from the NZCT for this project - this was very much appreciated and added significantly to the project.

Following on from consistent feedback from the tennis community, Tennis NZ has increased investment into marketing and promotion of our sport. An overarching marketing campaign has been developed and a soft launch is scheduled for October 2019. In addition Tennis NZ has committed both investment and time into elevating the Love Tennis campaign to a National weekend event. We were delighted that over 120 clubs throughout NZ took part during September and the results will be confirmed at the 2019 AGM.

The Roles and Responsibility Review, the objective of which was 'to identify the optimal sustainable delivery model and governance structure for Tennis in New Zealand to support the agreed Strategic Framework' has been completed. The results and recommendations are available on the Tennis NZ web site. Some of the recommendations will require change to the Tennis NZ Constitution and this work will be initiated after the 2019 AGM. With the support of the tennis community, we will be presenting these changes to the 2020 AGM.

Throughout 2018 we have seen New Zealand's doubles players continue to perform strongly at the professional level of our sport internationally. Michael Venus' outstanding 2018 campaign drew to a close when Michael and Raven Klaasen were eliminated in the group stage of the year-end ATP World Tour finals. The highlight of the Venus/Klaasen campaign in 2018 was a runner-up finish at Wimbledon in a five-set marathon loss to the team of Bryan/Sock.

Marcus Daniell has impressed also with runner-up finishes at Stockholm, Budapest and s'Hertogenbosch to complement an ATP 250 doubles title in Brisbane in January with partner Wesley Koolhof.

Artem Sitak's twelve months have been highlighted with two titles at Newport and Antayla alongside Jonathan Erlich at both events.

Paige Hourigan has been successful at multiple events over 2018/19, with her singles ranking climbing steadily to a careerhigh of 408 in May, 2019.

Erin Routliffe has consistently hovered on the edge of top 100 WTA doubles level and in the 120's at the time of writing.

Valentina Ivanov's emergence has continued with a Federation Cup debut and a steady climb up the WTA singles ranking to sit around the #738 mark back in January 2019.

New Zealand's re-entry into the Fed Cup continued under the stewardship of new captain, Sacha Hughes. A close but ultimately unsuccessful performance in the pool stage against Hong Kong means New Zealand is in Asia-Oceania Group 2 for a further 12-month period. Erin Routliffe, Paige Hourigan, Emily Fanning and Valentina Ivanov represented New Zealand in Malaysia with the team defeating Malaysia in the third place playoff on the final day.

New Zealand suffered a close Davis Cup loss to South Korea in September 2018 in Gimcheon, South Korea. Rubin Statham's proud record of Davis Cup representation continued and Ajeet Rai's debut performance in Davis Cup was outstanding.

New Zealand's Junior Davis and Fed Cup teams were captained by Alistair Hunt and Sacha Hughes respectively. Our Junior Davis Cup and Junior Fed Cup team's both finished 5th and 9th in their respective tournaments.

#### FINANCIAL PERFORMANCE

For the 208/19 financial year, Tennis NZ achieved a surplus of \$373K (after depreciation) largely due to again not hosting a home Davis Cup and a significant increase in TAB returns.

We're excited to be investing this surplus to undertake new projects that will benefit the tennis community, including the long-awaited return of ITF professional events to New Zealand in the form of the World Tennis Tour and increased services for clubs and coaches through more investment in Clubspark technology and enhanced support for Hot Shots venues and coaches.

We sincerely thank long term sponsors AON and Wilson for their confirmed commitment for another two years and welcome World Travellers, ASICS, SKY TV and Hell Pizza to the Tennis NZ family of commercial partners. These organisations contribute much to tennis in New Zealand and we encourage our tennis community to support them wherever possible. Trust funding continues to be an important source of income and we thank all of the funding partners who have supported us over the last twelve months. A full list of funding partners and sponsors is available at the back of this document.

TAB funding has progressively increased through the year following on from the new App launched in January. The Board will continue to take a watching brief on the reliance of Tennis NZ on this revenue stream. Tennis NZ placed submissions with the Department of Internal Affairs following on from the Messara Report. We remain concerned about the future security of TAB revenue to sports as well as possible changes to Class 4 Gaming Rules and the impact this might have for the wider sporting community.

#### **THANK YOU**

As always thanks must go to the Tennis NZ board members who are committed and passionate about our sport, and all willingly volunteer their time. At the 2019 AGM we will farewell our Chair of the past six years Celia Patrick, who is retiring after completing nine years on the board. The Board and staff of Tennis NZ sincerely thank Celia for her strong leadership and professional, committed contribution. Thanks also to the Tennis NZ staff - it is fantastic to see such an enthusiastic team committed to growing the sport and making a positive difference in the tennis community. Thanks again also to all of those who have been involved in various working groups and advisory boards throughout the year – you have all made a very positive contribution to growth and development of tennis in New Zealand.

# ENABLE PARTICIPATION

The 2018/19 year bucked the declining membership trend – overall participation in tennis increased by 3.3%, with membership growing by 1.9%. A variety of factors contribute to this – established national programmes, innovative clubs offering more appealing membership options, investment in coach development and volunteer training, and great initiatives like Love Tennis.

This past year has seen a huge increase in collaboration with Regions and Associations to support key national initiatives such as coach development, club capability, Hot Shots competitions and ClubSpark and Book a Court technology. Our sport depends on excellent, passionate people working in their local communities and our approach this year has been to encourage more aligned working. This approach means more momentum and success for everyone – He waka eke noa. We must be mindful to be innovative and keep adapting, being sure to cater for New Zealanders needs. Standards of communication, customer experience and a professional image have been a key focus of club and coach education.

We must continue to modernise our interactions with current and potential customers through efficient, intuitive websites and flexibility of offerings, otherwise customers will be left frustrated and look elsewhere – potentially at other leisure opportunities. We made some wonderful strides with ongoing and new projects in 2018/19 and are set up well to continue building momentum throughout the 2019/20 year.

#### **TECHNOLOGY**

#### ClubSpark

This year the nationwide roll out of ClubSpark began. The software is designed to ease a variety of administrative burdens for volunteers and time-poor coaches. At the end of 2018/19, 50 clubs were set up with ClubSpark accounts, 25 of these some of the largest membership clubs in NZ. Tennis NZ fully subsidises ClubSpark software for affiliated tennis clubs, and professional coaches registered to national participation programmes. 33 of these coaches were set up and are using ClubSpark this year.

ClubSpark is a fluid, global platform under continuous development by the London and Australia based ClubSpark team. The benefits of using software as a service (SAAS) is the flexibility it gives us, and the opportunities to make ongoing improvements, upgrades and enhancements. We have spent a long time working with ClubSpark to ensure that certain aspects of the product are up to minimum viable standards, and we continue to work with them to ensure the product caters for NZ tennis clubs in a beneficial way. As with any SAAS product, developments can take time and we have experienced

a few delays in the past 12 months with certain elements of functionality. With some patience and workarounds from clubs, the overarching benefits and potential of the software have largely outweighed any frustrations.

Through webinars and in person workshops, clubs and coaches continue to be onboarded and trained to use ClubSpark effectively. This results in more efficient running of clubs and coaching businesses and more professional engagement with customers through quality websites and online search, book and payment options for courses, memberships and courts.

#### **Book a Court**

Book a Court is a priority for Tennis NZ, based on research and feedback worldwide that shows tennis needs to be more accessible to non-members. In NZ 19-44-year olds are the biggest market who want to play tennis but currently don't. Perceived costs of joining a club, and the inability to book courts quickly and efficiently at short notice are putting these people off playing at all.

Over the 2018/19 summer, five clubs were invited to join the Book a Court pilot. Glenfield, Ngataringa, Te Pai Park, Manawatu Lawn and Stoke Tennis Clubs were identified as good test cases for the introduction of gate access technology. These venues are in populated locations with a relatively low member to court ratio, and all of them are extremely focussed on opening up their courts to casual players in the community.

Tennis NZ sees this as such a pivotal project for modernising tennis that we have committed to investing up to \$100,000 annually to subsidise the gate hardware cost to clubs by 80%. In addition we were able to secure \$50,000 from the NZCT to support this project in the 2018/19 FY. Original plans were for the pilot venues to be live in April/May 2019, but tech development took some time and we spent a few months working closely with ClubSpark UK, Australia and a local NZ tech company to get the API technology working – ultimately meaning that the gates could talk successfully to the internet and be enabled for the online bookings that were going to be made. Now, with a fully functioning API, the initial hold up of going live with Book a Court has passed, and we are looking for our next wave of clubs with a view to have 30 sites around NZ by the end of the 2019/20 financial year.

Book a Court allows members of the public to search, book and pay for courts online. Players then receive a unique pin code to punch in on arrival, making the process easy and stress free for players and club administrators alike! Book a Court will be going live at pilot and first phase clubs/venues at the start of the 2019 summer.



#### **CLUB CAPABILITY**

#### **Club Conference**

The inaugural National Club Conference was held in May 2019. To help with accessibility to more clubs, the conference toured to Auckland, Christchurch and Wellington. The Learn, Discuss, Connect concept was delivered through three workshop themes which clubs and tennis administrators had identified as priorities – Club Coach Relationship, The Customer Journey, Volunteer Environment. Expert speakers and Tennis NZ staff facilitated the workshops which reached 150 delegates from 64 tennis clubs.

#### **Club Toolkit**

An online club toolkit was a consistent request from the Roles and Responsibilities review in 2018. This is live on www. tennis.kiwi with resources on topics such as Club Coach Relationships, Love Tennis and Advocacy. More resources are added throughout the year as they are sourced from within and outside of tennis. Themes will include good governance, customer experience, volunteer recruitment, facilities, funding and much more.

#### **Love Tennis**

Love Tennis is a club open weekend concept which is fun and free for all ages, aimed at people who would like to try out or get back into tennis. Tennis Central launched Love Tennis in 2016 and were joined by Tennis Canterbury in 2017. After plenty of success in the two regions, Tennis NZ collaborated with Tennis Central towards the end of 2018 to make Love Tennis a national initiative and was held nationwide in September 2019 with 128 tennis clubs taking part. Some of the key objectives of the open weekend are:

- To encourage new, existing and returning participants of all ages, abilities, ethnicities and gender to come along to FREE weekend of tennis and give it a go.
- To raise the profile of tennis and to promote the many ways people can get involved in the game.
- To attract new and retain existing club members.

#### **NATIONAL PROGRAMMES**

It's been another big and successful year for national programmes. The resources and promotional material available to clubs and coaches continues to grow alongside quality volunteer training and coach development opportunities.

Tennis Hot Shots is gaining traction not only as a participation programme, but also as a player development programme. We continue to identify and support coaches delivering quality red, orange and green ball sessions.

230 New Zealand venues offer national programmes. This year we retained over 80% of last year's venues and grew new programme venues by 22%.

Importantly, 90% of programme deliverers (professional coaches and clubs), agree that programmes add value to their business or club. This, coupled with Hot shots parents' feedback that 95% of participants rate Hot Shots high or very high quality, gives us confidence that we have world class and proven products which enhance tennis in New Zealand.

A primary Tennis Hot Shots focus during 2018/19 was to make matchplay and competition a regular part of participation for young kids. Over time, coaching has become dominant, meaning the playing of tennis has reduced – with many young players not understanding tactics of the game and not having an outlet for the skills they have learnt. To this end, 10 competition themes have been developed for clubs and coaches including fun events like Monster Smash and Easter Hop Shots. Clubs were also encouraged to add a Hot Shots round robin category into their club championship – this was a huge success for the 10 clubs taking part this year. A Tennis Hot Shots competitive pathway guide will be published as a recommendation to all clubs, coaches, regions and associations in 2019-20.

### COACHING



#### **COACH DEVELOPMENT OVERVIEW**

Tennis NZ connects the coaching community through national programmes and local coach forums as well as providing development opportunities to both existing and aspirant coaches in the form of short courses, internationally recognised qualifications and extension modules. These opportunities are delivered locally by highly trained Coach Developers. Here is a snapshot of 2018-19;

#### Courses

- 178 aspiring new coaches completed the 2hr Coaching Fundamentals online course, this was an increase of 76% from 2017-18 (101 coaches).
- 16 Coaching Assistant Courses (3-day course) were
  delivered to a total of 170 participants, this was
  an increase of 113% from 2017-18 (7 courses/80
  participants). With the assistance of a growing Coach
  Developer network, this course was delivered in every
  region across New Zealand.
- Two Junior Development Coaching Courses (ITF Level 1) were delivered in 2018-19 to 24 participants.
   Students that are eligible to register for and deliver Tennis NZ national programmes (Hot Shots, Cardio Tennis and Tennis Xpress).
- The Club Professional Coaching Course (ITF Level 2) course was delivered for the first time in four years. Five coaches are currently undertaking this course which focuses on player development and the professional management of a tennis business.

#### **Extension Modules (Coach Workshops)**

Outside of the formal coaching courses it has been a strategic focus of Tennis New Zealand to offer more modular learning opportunities in the form of 2-hour, halfday and one-day Coach Forums and Workshops.

- 12 extension modules were delivered across New Zealand in 2018-19 with 229 coaches in attendance. Topics included Cardio Tennis, Hot Shots Schools, Coaching and Tournaments/Competitions, Inclusion (Wheelchair Tennis), High-Performance and Business.
- The national coach workshop series saw the Tennis NZ team visit coaches in Auckland, Hamilton, Hawkes Bay, Wellington and Christchurch. Tennis NZ would like to recognise Sport New Zealand for their generous support.



#### **ASB Classic Coaches Conference**

A new initiative in 2018-19 was the launch of the ASB Classic Coaches Conference. A partnership between Tennis Auckland, Tennis Coaches New Zealand (TCNZ) and Tennis New Zealand, 55 coaches attended the conference and were able to take in a range of presentations from local and international specialists from Foundation through to High-Performance. Following the conference, delegates attended a networking event celebrating the 50-year anniversary of TCNZ followed by a night watching the tennis at the ASB Classic.

#### **Coach Developers**

Growing and developing the Coach Developer network has been a key focus as it allows sustainable, consistent, local delivery of the Coach Development framework across New Zealand.

- Tennis New Zealand now has 10 contracted Coach Developers, this is up 150% (from 4 in 2017-18).
- There are now 4 female contracted Coach Developers (up from 0 in 2017-18).



### **TOURNAMENTS & EVENTS**

Tennis NZ is always looking to expand the offering of competitive options and to build tournaments and events for all genders, ages, levels and aspirations of player.

#### **TOURNAMENT REVIEW**

Tennis NZ recently conducted a tournament review with the focus of developing a modern and attractive competitive pathway. The review looked at all levels of tournaments and events, with a focus on athletes competing in more competitive matches more often.

Starting with analysing overall competitiveness of a match, which was defined as 19 games, or a 6-3 6-4 minimum score, Tennis NZ reviewed 19,000+ matches from April 2016 to February 2017. It was found that 32% of all matches were competitive, and as players compete against other players of similar standard (MatchHub Grade) this percentage went up. Conversely as the grade difference exceeded +-2 grades, the competitive dropped significantly to <9%. Results from this analysis shaped a tournament pilot structure which has been conducted across numerous cities and levels of tournaments throughout New Zealand.

The tournament pilot structure focuses on maximising the overall number of matches competed being +-2 grades for all players. The introduction of minimum grade requirements for Junior Masters Tier 2 and Tier 3 events achieved a 97% average (92% minimum and 98% maximum) for matches at +-2 grades. Events that did not participate in the pilot structure had an average of 89% (73% minimum and 98% maximum) for matches at +-2 grades.

The tournament pilot structure is continuing for 2019/20, and decisions on implementing any significant changes will occur early 2020 for July 2020.

### PASCOES NEW ZEALAND TENNIS CHAMPIONSHIPS

The pinnacle achievement for our athletes is being crowned New Zealand Champion. Each year these Championships are held in December, with the 2018 event having all rounds at Albany Tennis Park.

2018 saw womens third seed and 17-year-old Valentina Ivanov defeating first seed Paige Hourigan in a thrilling final battle, coming away with the title and a 3-6 6-4 7-5 win. Winning the 2018 Womens Singles meant that Ivanov received a Qualifying Wild Card into the 2019 ASB Classic

Womens Singles event in January 2019. Hourigan received a discretionary Wild Card for the same event, and the two were drawn to play each other in the first round of qualifying, with Ivanov coming away the winner again, 4-6 6-3 6-3. Ivanov then fell to Biblane Schoofs from the Netherlands 6-4 6-0.

In the mens singles draw, 2nd seed Finn Tearney defended his 2017 champions title against 22-year-old Alex Klintcharov. Tearney's greater experience and big match temperament proved the difference, winning the final 6-1 6-3. Tearney also received a Qualifying Wild Card into the 2019 ASB Classic Mens Singles event, falling to Italy's Thomas Fabbiano 6-3 6-4 in the first round.


### NEW ZEALAND JUNIOR CHAMPIONSHIPS 12U, 14U, 16U, 18U

The pinnacle achievement for our juniors is winning their age group championships. Kiwi juniors train throughout the year to ensure they peak during these prestigious events.

Tennis New Zealand host these Junior Championships throughout the country, with recent emphasis being on ensuring all juniors have a fantastic experience while competing at the event. This has been achieved consistently each year through the introduction of a Qualifying and Main Draw structure, the addition of a Tier 3 Junior Masters tournament for players who are lower ranked and the introduction of a Mixed Doubles event for the 12U, 14U and 16U age groups.

Each year these events are hosted at either Scarbro Tennis Centre in Auckland or Trustpower Wilding Park Tennis Centre in Christchurch for the 12U, 14U and 16U events, and Albany Tennis Park for the 18U event.

#### **SECONDARY/PRIMARY SCHOOLS**

National Secondary Schools Teams Final is held during NZSSSC Summer Tournament Week each year. 2018 saw a change in the qualifying structure from a regionally based draw to a minimum MatchHub grading requirement. This resulted in more schools having access to the Championship event, if they met the grading criteria. A Cup event was also introduced with no grading requirement and smaller teams (2 or 3 instead of 4 or 5). This allowed smaller schools to have access to a secondary school tennis national experience, with 17 additional teams being added to the event. The 2019 event was held in Christchurch at Trustpower Wilding Park in March.

Primary/Intermediate Island Finals are held throughout November, with players qualifying through their local Associations, then Regional qualifying events. The 2018 North Island Finals were held at the Renouf Tennis Centre in Wellington, and the South Island Finals were in Timaru at the South Canterbury Tennis Centre. This event has been discontinued from 2019 with the AIMS Games now determining New Zealand's Intermediate Schools Champion.

#### **MASTERS**

Over the Labour Day Weekend, our Junior Masters players in the 12s, 14s and 16s ages competed at Waikato Tennis Centre, Hamilton to become 2018 Junior Masters Champion. The event had some fantastic tennis with 194 matches played over the 3 days. This years event was one of the best, with the Finals continuing to include a 9-16 Finals group in the 12s and 14s Boys and Girls. In all of the age groups, the number one or two seed won the Final.

#### **ELITE LEVEL**

2018-19 has seen New Zealand's doubles players continue to perform strongly at the elite level of our sport internationally. Michael Venus' outstanding 2018 campaign drew to a close when Michael and Raven Klaasen were eliminated in the group stage of the year-end ATP World Tour finals. The highlight of the Venus/Klaasen campaign in 2018 was a runner-up finish at Wimbledon in a five-set marathon loss to the team of Bryan/Sock. Michael and Raven have powered through the first six months of 2019 in strong fashion, quarter-finalists at the Australian Open, runners-up in Auckland and Rome and victorious in Halle, leaving them extremely well-placed to qualify for the year-end finals once more.

Marcus Daniell has impressed also with runner-up finishes at Stockholm, Budapest and s'Hertogenbosch to complement an ATP 250 doubles title in Brisbane in January with partner Wesley Koolhof.

Artem Sitak's twelve months have been highlighted by two tiles at Newport and Antayla alongside Jonathan Erlich at both events.

Paige Hourigan has experienced success at multiple events over 2018/19, capped off by tournament title in singles twice over in Portugal and Mexico and complemented by doubles titles secured in Singapore, USA, Mexico and Hong Kong. Paige's singles ranking has climbed steadily to a career-high ranking of 408 in May, 2019.

Erin Routliffe has consistently hovered on the edge of top 100 representation at WTA doubles level over the course of the twelve months and Erin's doubles ranking sits in the 120's at the time of writing.

Valentina Ivanov's emergence has continued with a Federation Cup debut and a steady climb up the WTA singles ranking to sit around the #738 mark back in January.

#### FED CUP / DAVIS CUP

New Zealand's re-entry into the Fed Cup fold continued with our visit to Malaysia in June under the leadership of new captain, Sacha Hughes. A close but ultimately unsuccessful performance in the pool stage against Hong Kong consigned New Zealand to Asia-Oceania Group 2 for a further 12-month period. Erin Routliffe, Paige Hourigan, Emily Fanning and Valentina Ivanov represented New Zealand in Malaysia an the team defeated Malaysia in the 3rd place playoff on the final day. New Zealand suffered a heartbreakingly close Davis Cup loss to South Korea in September in Gimcheon, South Korea in September.

Rubin Statham's proud record of Davis Cup representation continued and his level of tennis on the first day gave New Zealand an early lead. After Michael Venus was beaten in a lengthy three set battle, the teams ended day one locked up at 1-1. Ajeet Rai's debut performance in Davis Cup was outstanding with an injury to Marcus Daniell forcing a late change to the doubles line-up. Ajeet and Artem Sitak handed New Zealand a 2-1 lead at the conclusion of the doubles. Rubin Statham and Michael Venus were outpointed in the final two singles rubbers which meant that New Zealand was relegated to Asia-Oceania Group Two for 2019.

#### **JUNIORS**

International junior representation continues to be a strong focus within athlete development. New Zealand's Junior Davis and Fed Cup teams were captained by National Coach Christophe Lambert.

Our Junior Davis Cup team of Jay Friend, Aulkie Wang and Corban Crowther finished 5th of 16 teams in Bangkok, Thailand. Our Junior Fed Cup team of Jade Otway, Abby Mason and Ana Tamanika finished 9th of 16. World Junior Teams on the male side consisted of Jack Chapman, Alex Mirkov and Diego Quispe-Kim and this team was captained by Matt Alexander. The female World Junior Team representatives were Vivian Yang, Sasha Situe and Renee Zhang and this squad was captained by Sebastian Lavie. The world junior teams Asia-Oceania qualifying event was held in Kuala Lumpur, Malaysia.

#### ATHLETE DEVELOPMENT

2019 marked a further evolution in athlete development within New Zealand with increasing levels of flexibility within the pathway. This was evidenced by an additional level of the athlete development criteria (silver) and the advent of Davis and Fed Cup development squads to further support our elite juniors as they prepare to embark on their post-junior careers. In addition, financial support is available to high-performing athletes by way of the world tennis tour support scheme. A continued commitment toward rewarding National representation has seen 35+ athletes receive funding support toward their travel to represent New Zealand internationally. In addition to the athlete support on these official tours, we have also seen the emergence of outstanding performance-minded coaches that have accompanied our athletes overseas and delivered world-class care and information throughout.

#### **SPECIAL RECOGNITION:**



Tennis NZ presented the Spirit of Tennis Award to Kevin Woolcott. Kevin started coaching full time in 1978 following a long and distinguished playing career that included Davis Cup representation and playing stints at Wimbledon and the Australian Open. He was also a former National Coach of New Zealand, from 1983-1989. Included in his National Representative team duties have been stints as the Fed Cup Captain of New Zealand.

From 1992-2001 was the Northern Regional Coach, incorporating North Harbour and Northland. In 2000, Kevin and business partner Sue Nixon formed Tennislife Coaching Ltd. Tennis life was named as a finalist of the 2008 Westpac Enterprise Business Excellence Awards (Innovation category). He was named as a life member of Tennis Northern in 2017, has been a life member of TCNZ since 2011 and was made a life member of the Upper Hutt Tennis Club in 1983.



# NOTES TO THE ACCOUNTS

AS AT 30<sup>TH</sup> JUNE 2019

#### 1. REPORTING ENTITY

The reporting entity is Tennis New Zealand Inc. ("Tennis NZ"). Tennis New Zealand is domiciled in New Zealand and is a charitable organisation registered under the Incorporated Societies Act 1908 and the Charities Act 2005.

The financial statements of Tennis NZ are presented for the year ended 30 June 2019. These financial statements and the accompanying notes summarise the financial results of activities carried out by Tennis NZ which provides tennis sporting services and facilities to people living in the wider New Zealand area.

These financial statements have been approved and were authorised for issue by the Board of Directors on the 22nd August 2019.

# 2. STATEMENT OF COMPLIANCE

The financial statements have been prepared in accordance with Generally Accepted Accounting Practice in New Zealand ("NZ GAAP"). They comply with Public Benefit Entity International Public Sector Accounting Standards ("PBE IPSAS") and other applicable financial reporting standards as appropriate that have been authorised for use by the External Reporting Board for Not-For-Profit entities. For the purposes of complying with NZ GAAP, the Group is a public benefit not-for-profit entity and is eligible to apply PBE IPSAS RDR on the basis that it does not have public accountability and it is not defined as large. The Board of Directors has elected to report in accordance with PBE Accounting Standards RDR.

# 3. SIGNIFICANT ACCOUNTING POLICIES

The significant accounting policies used in the preparation of these financial statements as set out below have been applied consistently to both years presented in these financial statements.

### 3.1 Basis of measurement

These consolidated financial statements have been prepared on the basis of historical cost, as modified by the fair value measurement of non-derivative financial instruments.

## 3.2 Functional and presentational currency

The financial statements are presented in New Zealand dollars (\$), which is Tennis New Zealand's functional currency. All financial information presented in New Zealand dollars has been rounded to the nearest dollar.

# 3.3 Revenue

Revenue is recognised to the extent that it is probable that the economic benefit will flow to Tennis NZ and revenue can be reliably measured. Revenue is measured at the fair value of the consideration received. The

following specific recognition criteria must be met before revenue is recognised.

# Revenue from non-exchange transactions

#### **Donations**

Donations are recognised as revenue upon receipt and include any donations from the general public, or donations received for specific programmes or services.

#### Grant Revenue

Grant revenue includes grants given by other charitable organisations, philanthropic organisations and businesses. Grant revenue is recognised when the conditions attached to the grant have been complied with. Where there are unfulfilled conditions attaching to the grant, the amount relating to the unfulfilled condition is recognised as a liability and released to revenue as the conditions are fulfilled.

#### TAB Revenue

The TAB income is from commission on tennis betting and is recognised as revenue when entitled to be received.

# Revenue from exchange transactions

#### Affiliation Fees

Affiliation fees received are initially recorded as income in advance and recognised in revenue evenly over the membership period.

Where coaches purchase specific services (for example, attendance at coaching and development courses), revenue is initially recorded as revenue in advance, and then recognised proportionally on the basis of the value of each session relative to the total value of the purchased services.

### Interest Income

Interest revenue is recognised as it accrues, using the effective interest method.

# 3.4 Financial Instruments

Financial assets and financial liabilities are recognised when Tennis NZ becomes a party to the contractual provisions of the financial instrument.

Tennis NZ derecognises a financial asset or, where applicable, a part of a financial asset or part of a group of similar financial assets when the rights to receive cash flows from the asset have expired or are waived, or Tennis NZ has transferred its rights to receive cash flows from the asset or has assumed an obligation to pay the received cash flows in full without material delay to a third party; and either:

- Tennis NZ has transferred substantially all the risks and rewards of the asset; or
- Tennis NZ has neither transferred nor retained substantially all the risks and rewards of the asset, but has transferred control of the asset.

#### Financial Assets

Financial assets within the scope of PBE IPSAS 29
Financial Instruments: Recognition and Measurement
are classified as financial assets at fair value through
surplus or deficit, loans and receivables, held-to-maturity
investments or available-for-sale financial assets. The
classifications of the financial assets are determined at
initial recognition.

#### Loans and Receivables

Loans and receivables are non-derivative financial assets with fixed or determinable payments that are not quoted in an active market. After initial recognition, these are measured at amortised cost using the effective interest method, less any allowance for impairment. Tennis NZ's cash and cash equivalents, short-term investments, receivables from non-exchange transactions, receivables from exchange transactions and non-equity investments fall into this category of financial instruments.

#### Impairment of financial assets

A financial asset or a group of financial assets is impaired and impairment losses are incurred if there is objective evidence of impairment as a result of one or more events that occurred after the initial recognition of the asset (a 'loss event') and that loss event has an impact on the estimated future cash flows of the financial asset or the group of financial assets that can be reliably estimated.

For financial assets carried at amortised cost, if there is objective evidence that an impairment loss on loans and receivables carried at amortised cost has been incurred, the amount of the loss is measured as the difference between the asset's carrying amount and the present value of the estimated future cash flows discounted at the financial asset's original effective interest rate. The carrying amount of the asset is reduced through the use of an allowance account. The amount of the loss is recognised in the surplus or deficit for the reporting period.

If in a subsequent period, the amount of the impairment loss decreases and the decrease can be related objectively to an event occurring after the impairment was recognised, the previously recognised impairment loss is reversed by adjusting the allowance account. If the reversal results in the carrying amount exceeding its amortised cost, the amount of the reversal is recognised in surplus or deficit.

#### Financial liabilities

Tennis NZ's financial liabilities include trade and other creditors (excluding GST and PAYE), employee entitlements and deferred income (in respect to grants whose conditions are yet to be complied with).

All financial liabilities are initially recognised at fair value (plus transaction cost for financial liabilities not at fair value through surplus or deficit) and are measured subsequently at amortised cost using the effective interest method.

### 3.5 Cash and Cash Equivalents

Cash and cash equivalents are short term, highly liquid investments that are readily convertible to known amounts of cash and which are subject to an insignificant risk of changes in value.

# 3.6 Property, Plant and Equipment

Items of property, plant and equipment are measured at cost less accumulated depreciation and impairment losses. Cost includes expenditure that is directly attributable to the acquisition of the asset.

Depreciation is charged on a straight-line basis over the useful life of the asset. Depreciation is charged at rates calculated to allocate the cost or valuation of the asset less any estimated residual value over its remaining useful life:

- Sporting equipment 3 years
- Office Furniture / equipment -5 years
- Computer equipment / Software 3 years

Depreciation methods, useful lives and residual values are reviewed at each reporting date and are adjusted if there is a change in the expected pattern of consumption of the future economic benefits or service potential embodied in the asset.

### 3.7 Intangible Assets

Intangible assets acquired separately are measured on initial recognition at cost. The cost of intangible assets acquired in a non-exchange transaction is their fair value at the date of the exchange.

Following initial recognition, intangible assets are carried at cost less any accumulated amortisation and accumulated impairment losses.

The useful lives of intangible assets are assessed as either finite or indefinite. Intangible assets with finite lives are amortised over the useful economic life and assessed for impairment whenever there is an indication that the intangible asset may be impaired. A review is made at least at the end of each financial period.

The amortisation expense on intangible assets with finite lives is recognised in surplus or deficit as the expense category that is consistent with the function of the intangible assets. Tennis NZ does not hold any intangible assets that have an indefinite life.

# 3.8 Employee Benefits

# Wages, salaries, annual leave and sick leave

Liabilities for wages and salaries, annual leave and accumulating sick leave are recognised in surplus or deficit during the period in which the employee provided the related services. Liabilities for the associated benefits are measured at the amounts expected to be paid when the liabilities are settled.

#### 3.9 Income Tax

Due to its charitable status, Tennis NZ is exempt from income tax.

# 3.10 Goods and Services Tax (GST)

Revenues, expenses and assets are recognised net of the amount of GST except for receivables and payables, which are stated with the amount of GST included.

The net amount of GST recoverable from, or payable to, the Inland Revenue Department is included as part of receivables or payables in the statement of financial position.

Cash flows are included in the statement of cash flows on a gross basis and the GST component of cash flows arising from investing and financing activities, which is recoverable from, or payable to, the Inland Revenue Department is classified as part of operating cash flows.

# 3.11 Equity

Equity is the members interest in Tennis NZ, measured as the difference between total assets and total liabilities. Equity is made up of the following component:

Accumulated comprehensive income and expenses. This is Tennis NZ's accumulated surplus or deficit since its formation, adjusted for transfers to/from specific reserves.

# 3.12 Financial Accounting Standards

There were no new PBE IPSAS RDR standards that became effective in the current year that have an impact upon the Tennis New Zealand financial accounts.

# 4. SIGNIFICANT ACCOUNTING JUDGEMENTS, ESTIMATES AND ASSUMPTIONS

The preparation of Tennis NZ's financial statements requires management to make judgements, estimates and assumptions that affect the reported amounts of revenues, expenses, assets and liabilities, and the accompanying disclosures, including the disclosure of contingent liabilities. Uncertainty about these assumptions and estimates could result in outcomes that require a material adjustment to the carrying amount of

assets or liabilities affected in future periods.

# **Judgements**

In the process of applying Tennis NZ's accounting policies, management has made the following judgements, which have the most significant effect on the amounts recognised in the financial statements.

### Operating lease commitments

Leases in terms of which Tennis NZ does not retain all the significant risks and rewards of ownership, are accounted for as operating leases.

Operating lease rentals are recognised evenly over the expected period of the benefit to the organisation. In the event that lease incentives are received to enter into operating leases, such incentives are initially recorded as a liability and are recognised as a reduction of rental expense on a straight-line basis over the term of the lease.

#### Estimates and assumptions

The key assumptions concerning the future and other key sources of estimation uncertainty at the reporting date, that have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities within the next financial year, are described below. Tennis NZ based its assumptions and estimates on parameters available when the financial statements were prepared. Existing circumstances and assumptions about future developments, however, may change due to market changes or circumstances arising beyond the control of Tennis NZ. Such changes are reflected in the assumptions when they occur.

Tennis Otago Incorporated and Tennis Southern Region Incorporated have been granted a deferment of payments of loan principal and waiver of interest to 30th June 2019.

The combined Tennis Southern Region and Tennis Otago Incorporated loans will not be fully recovered and therefore, a provision for write down of \$50,000 was made in the 2012 accounts.

A further provision of \$13,290 has been made in the 2018 accounts.

Tennis Northern Region Loan held by Tennis Charitable Trust. Following agreement with Tennis Charitable Trust, as from 1st January 2019, previous monthly interest payments have been applied to the loan repayment. As from 1st July the principal repayments increased to \$4,000 per month.

The Loans have been classified as Non-Current Assets as funds are not expected to be received within the next twelve months.
